

RELEASE AND WAIVER OF LIABILITY and ASSUMPTION OF RISK AGREEMENT ("AGREEMENT")

IN CONSIDERATION of contracting with Fur Nanny Professional Pet and House Concierge, LLC ("Fur Nanny") to care for my pet(s) while I am away from home and/or unable to do so myself, I:

- 1) ACKNOWLEDGE, agree, and represent that one or more my pets spends a portion or all of any given 24-hour period outside of the confines and security of my home by either:
 - a) Living entirely outside, never or rarely entering my home; or
 - b) Is/are freely granted access to the outside through a conventional dog-door or other type of opening, allowing the pet(s) to come into or leave the confines and security of my home; or
 - c) Is/are securely contained on my property by way of secure physical or radio-wave fence, or other secure enclosure.
- 2) FULLY UNDERSTAND THAT: (a) FUR NANNY CAN NOT AND WILL NOT BE RESPONSIBLE OR LIABLE IN ANY WAY for the activities of my pet(s) while the animal(s) is/are not under the direct supervision and control of Fur Nanny or its administrators, agents, contractors, or employees (collectively referred to as "Releasees").
- 3) HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE FUR NANNY OR RELEASEES from/for any and all financial responsibility, liability, claims, demands, losses, or other damages made or sought by me or other involved parties as a result of damage caused by or to my pet(s).
- 4) I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my pet(s) being given such carte blanche access to unsupervised activity.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID BY MUTUAL AGREEMENT OF BOTH MYSELF AND FUR NANNY, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
